A Regular Meeting of the Board of Supervisors was called to order February 15, 2018, at 9:00 a.m.

Supervisor Dennis Vasey, Chairman; Supervisor Nancy Richie, Treasurer, Supervisor James Lang, Secretary, and Supervisor Robert Griffin were present.

Also present were Agricultural MIL Supervisor/District Administrator Mark Siverling, Urban MIL Supervisor James Nikolich, and Agricultural MIL Technician Paul Hayden.

III. Approval of Agenda:

V. **Public Comments**: Mr. Westbrook briefly discussed water issues in Ohio and Florida.

VI. Reports:

- a. District Conservationist Report: The acting DC was unable to attend.
- b. Financial (written report): The bookkeeper was not able to produce the financial report in time for the meeting.
- c. District Status Report: Mark Siverling said that the Agricultural and Urban Mobile Irrigation Labs (MILs) are getting out in the field and catching up on evaluations after last year's hurricane. He reported that NRCS and Collier County staff are in negotiations about storing the District's equipment in the damaged office building. Mr. Nikolich reported that he has been helping repair the building's water system and keeping a good working relationship with the University of Florida staff.
- d. Community Outreach: Mr. Siverling said that the MILs are involved with the Greenscape Alliance and attend the monthly Citrus Seminars at the UF Research Center in Immokalee.

VII. Old Business:

- a. FDACS Reimbursement Process: Mr. Siverling reported that he and CPA Mark Stout have been working with FDACS to supply the needed documentation for the work performed July-September 2017 and October-December 2017. FDACS has not asked for more documents, but payment has not yet been received.
- b. Supervisor Vasey reported that he has been in contact with Representative Passidomo regarding the inclusion of Special Districts in the proposed expansion of the state insurance program.

- a. Wildfire Awareness: Chairman Vasey and Supervisor Griffin led a discussion about funding fire protection in unincorporated areas.
- b. Employee Handbook Update: Mr. Siverling reported that the Employee Handbook needs to be updated to reflect the new twice-monthly pay schedule. Chairman Vasey said that the language can be updated without a Board vote. Mr. Hayden expressed concern about the number of working days differing from year to year, and Mr. Vasey said that a separate check can be cut to correct any year-end discrepancies.
